Booking Conditions: This is an agreement between the undersigned, hereafter referred to as "Customer", and Oliver Higgins, hereafter referred to as "Photographer". Customer agrees to meet with the photographer seven (7) days or less prior to the wedding to provide address and directions to all wedding locations, special photo requests and time of wedding events. It is understood that the Photographer is the exclusive official photographer, and others taking photographs will be permitted only at the discretion of Photographer. Photographer reserves the right to use negatives and/or other reproductions for display, publication, or any other purpose. Finished DVD's will not be delivered until payment is made in full. Should the Customer cancel the Photographer's services for the wedding date specified in the Agreement, it is agreed that the retainer paid to the Photographer will not be refunded. Photographer takes the utmost care with respect to the exposure, development and delivery of photographs; however, in the event the Photographer fails to comply with the terms of the Agreement, for any reason, the Photographer's liability is limited to refund of all monies paid by Customer. Additional time is charged at an hourly rate. Remaining balance is due maximum seven (7) days before event date. Holding fees and interest may incur if albums and photographs are not picked up three (3) months from the event date. Photographer has the right to assign another photographer if in the event of an emergency. Photographer is not liable for any accident, injury or damage whatsoever that may occur during the course of the assignment to any person or property. The Photographer will remain the owner of all images.
